A MATHEMATICAL FUZZY MODEL TO STUDY THE EFFECT OF FISH CONSUMPTION ON CORONARY HEART DISEASE MORTALITY IN MOROCCO

ABSTRACT. The association between fish consumption and Coronary Heart Disease (CHD) due to $n - 3$ polyunsaturated fatty acids, especially fatty, fish consumption may be responsible for protecting against death from CHD.
